1. General

These Invoice Terms and Conditions ("Terms") apply to all sales and services provided by S & R MOTORS (STRATTON) LIMITED ("we", "us", "our") unless otherwise agreed in writing. By accepting our invoice, you agree to these Terms.

2. Payment Terms

- Payment is due in full within 30 days from the date of the invoice unless otherwise agreed in writing.
 - We reserve the right to charge interest on overdue payments at the rate of 8% above the Bank of England base rate, accruing daily until payment is made in full.
 - All payments must be made in pounds sterling (GBP).

3. Invoices

- Invoices will be issued for goods supplied or services rendered.
 - It is the customer's responsibility to ensure all details on the invoice are correct. Any discrepancies should be reported within 7 days of the invoice date.
 - If no notification of a dispute is received within this period, the invoice will be deemed accepted.

4. Delivery and Risk

- Risk in goods passes to the customer upon collection or delivery to the address specified in the order.
 - We shall not be liable for any loss or damage to goods once risk has passed to the customer.

5. Title

- Ownership of goods supplied shall not pass to the customer until full payment of the invoice and any other sums owed to us by the customer has been received.
 - Until ownership passes, we reserve the right to repossess the goods.

6. Returns and Cancellations

- Returns or cancellations must be agreed in writing prior to the return of any goods.
 - Goods returned without prior agreement may not be accepted and may be subject to a handling charge.
 - Custom or specially ordered goods are non-returnable unless faulty.

7. Liability

- Our liability is limited to the replacement or repair of faulty goods or re-performance of services.
 - We shall not be liable for any indirect, consequential, or special losses arising from the supply of goods or services.

8. Force Majeure

We shall not be liable for any delay or failure to perform due to circumstances beyond our reasonable control, including but not limited to acts of God, strikes, or supply chain disruptions.

9. Governing Law and Jurisdiction

These Terms shall be governed by and construed in accordance with the laws of England and Wales. Any disputes arising under or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of England and Wales.
